Minutes of the Rescheduled Board Meeting of the Board of Commissioners of the Housing Authority of the City of Freeport April 7, 2017

The Rescheduled Board Meeting of the Board of Commissioners of the Housing Authority of the City of Freeport was held on Friday, April 7, 2017 at the HACF Administrative Office in the Empowerment Center located at 1052 W. Galena Avenue, Freeport, Illinois at 12:00 p.m. Interim Chair Smith-Norman called the meeting to order at 12:06 pm. The following members were present in person at roll call: Interim Chair Jennifer Smith-Norman, Interim Vice-Chair Greta Harrell, Commissioner Roger Schulz, Commissioner Patrick McDermott, Commissioner Don Beckington, and Commissioner Tiffany Nieman. Others present were Chief Executive Officer Larry Williams and Executive Assistant Brenda Westfall and General Counsel Jim Pirages and Kelly Hintzsche. Commission Newton was absent at roll call and arrived prior to the election vote for Chair.

Mr. Williams noted to everyone present that Steve Carroll, who was in attendance, was video recording the meeting.

A motion was made by Commissioner Nieman to approve the agenda by amending in moving the Public Comment to be after Approval of Minutes and the motion was seconded by Commissioner Schulz. Interim Chair Smith-Norman declared the Motion carried by voice vote.

Commissioner McDermott made a motion to approve the March 10, 2017 Regular Board Meeting minutes with said correction by Interim Vice-Chair Harrell of striking the sentence in Communications "[Commissioner Harrell's original statement made in the meeting was not provided.]". Commissioner Nieman seconded the motion. Interim Chair Smith-Norman declared the Motion carried by voice vote.

Interim Chair Smith-Norman suggested the March 23, 2017 Special Board Minutes should note there was discussion on Odessa Walker's resignation and Mr. Williams discussed re-hiring if she isn't elected. Commissioner Nieman made a motion to approve the March 23, 2017 Special Board Meeting minutes as amended per Interim Chair Smith-Norman. Commissioner Schulz seconded the motion. Interim Chair Smith-Norman declared the Motion carried by voice vote.

Public Comment: None

Election of Officers:

Mr. Williams did not receive any nominations for Chair or Vice-Chair. Nominations were asked for Chair. Interim Vice-Chair Harrell nominated Smith-Norman for Chair. Commissioner Nieman nominated Commissioner Schulz for Chair. No other nominations were made for Chair. Interim Chair Smith-Norman closed the nominations. Discussion was held with concern that Commissioner Schulz is finishing a term and his term expires in October 2017 per City Council minutes and considered to table the election of officers to see clarification of term. Commissioners are on the Board until the Mayor makes a decision to change. Attorney Pirages referenced the Bylaws that Election of Officers is done at the annual board meeting.

The vote was Smith-Norman four (4) and Schulz three (3). Commissioner Smith-Norman was elected Chair.

Nominations for Vice-Chair were received. Chair Smith-Norman nominated Interim Vice-Chair Harrell. Commissioner Newton nominated Commissioner Schulz; Commissioner Schulz declined the nomination. Commissioner Beckington nominated Commissioner Newton. Interim Chair Smith-Norman closed the nominations.

Financial Review:

There are no March financials due to the March 31 fiscal year end; year end adjustments and accrual adjustments need to be made. The March payables reports are included. Chief Executive Officer Report:

Mr. Larry Williams' provided a verbal report. He read a manager's letter regarding a resident asking about EID. Mr. Williams reported multiple, anonymous blogs that are referencing EID and the blogs encourage residents to seek an attorney, suggesting they have been overcharged for rent. Mr. Williams asked the Board how they want to respond because Mr. Williams has already answered these questions for the Board and then the same questions and discussions are showing up on the blogs. Those doing the blogs also have Mr. Williams' private information of social security number and driver's license number. Mr. Williams won't respond to the blogs but will spend resources to discover who has his private information. Commissioner Schulz investigated and believes the blogs are under a pseudo name. Staff are spending time meeting with residents due to these blogs. Suggestion made to provide education on EID.

Old Business:

Affordable Housing Discussion – RAD Update

Mr. Williams reported at the last Special Board Meeting that the Board agreed to proceed with RAD in the Westview properties and to consider the land across from Westview. There is a lot of due diligence work to be done in the next 60 days. An update on Hosmer is that 14th floor is completed and residents have moved into their new rehabbed units on that floor.
